COPY OF RESOLUTION ADOPTED BY THE BOARD OF
COUNTY ROAD COMMISSIONERS OF THE COUNTY OF
OAKLAND, MICHIGAN, UNDER DATE OF

WHEREAS, **FOX BAY DRIVE, HURON RIVER DRIVE, MARIA DRIVE and PERRY BOULEVARD**, platted in Fox Bay Subdivision; **FOX BAY DRIVE**, platted in Riverdale Subdivision; **FOX BAY DRIVE** the UNPLATTED SECTION, Located East of Fox Bay Subdivision; **HURON RIVER DRIVE, HURON RIVER COURT, MARIA DRIVE and VANDEN DRIVE**, platted in Fox Bay No. 2 Subdivision; **HURON RIVER DRIVE and VANDEN DRIVE**, platted in Fox Bay No. 4 Subdivision; **VANDEN DRIVE**, platted in Hurondale Subdivision No. 1; and **VANDEN DRIVE**, platted in Hurondale Subdivision No. 2; all in Section 24, White Lake Township, Oakland County, Michigan, are public streets under the jurisdiction of the Board; and

WHEREAS, on May 30, 2023, the Board of County Road Commissioners received application by petition for a Special Assessment Improvement Project signed by owners of lineal footage of lands fronting or touching each and all of the described streets in excess of the required 51%; and

WHEREAS, this application by petition complies with the provisions of Act 246 of the Public Acts of 1931, State of Michigan, as amended, and as provided in the Policy and Procedure Manual for Special Assessment Improvement Projects as adopted by the Board; and

WHEREAS, said application by petition grants the authority to the Board to establish a special assessment district to have improvements made by contract, and to assess the benefiting property for the cost of said improvements by reason of benefits accruing from the proposed improvement; and

WHEREAS, by resolution under date of July 6, 2023, the Board did declare said petition to be valid and did make its preliminary determination that the proposed improvement is necessary for the benefit of the public and for public welfare and convenience; and

WHEREAS, an examination of the location of the proposed improvements, surveys, preliminary plans, specifications, a plat of the lands that may benefit and be assessed along with an estimate of the total project cost in the amount of \$1,576,443.75 for said improvements have been made; and

WHEREAS, said plat of lands that may benefit and be assessed and an estimate of the total project cost are hereby attached and made part of this order, and the surveys, preliminary plans and specifications are available in the Board's Engineering Department and are hereby incorporated in, and made part of this order; and

WHEREAS, in accordance with the provisions of Act 246, a Hearing shall be held at a time and place as determined by the Board for the purpose of hearing objections to or support for the proposed improvements, establishment of the assessment district, and determining the number of annual installments in which the money for the cost of said improvements shall be raised.

NOW, THEREFORE, BE IT RESOLVED, that this Board does hereby make its First Order of Determination and does determine and declare that the proposed improvements are necessary for the benefit of the public and for public welfare and convenience and that improvements be made to the aforementioned streets; and

BE IT FURTHER RESOLVED, that in accordance with the provisions of Act 246, a public Hearing on Objections will be held remotely via Microsoft Teams (810-337-8118; conference ID 590 503 057#) on the **23rd day of August, 2023, at 7:00 p.m.**; and

BE IT FURTHER RESOLVED, said Hearing on Objections will be conducted by a Hearing Examiner, as provided in the Policy and Procedure Manual for Special Assessment Improvement Projects as adopted by this Board; and

BE IT FURTHER RESOLVED, that this Board does hereby appoint Thomas R. Charboneau, Jr. of 2041 E. Square Lake Road, Suite 100, Troy, Michigan, to act as Hearing Examiner for the Hearing on Objections for the improvement of the aforementioned streets; and

BE IT FURTHER RESOLVED, that said Examiner shall submit findings of fact and proposed determinations to the Board in accordance with the Policy and Procedure Manual for Special Assessment Improvement Projects; and

BE IT FURTHER RESOLVED, this Board has determined that the following described parcels of land, lots numbering **1 through 38 inclusive, platted in Fox Bay Subdivision; 5 through 6 inclusive, 41 through 42 inclusive, and parcel with sidwell number 12-24-380-004, platted in Riverdale Subdivision; 78 through 119 inclusive, platted in Fox Bay No. 2 Subdivision; 145 through 151 inclusive, 161 through 174 inclusive, 180 through 184 inclusive, and Outlot with sidwell number 12-24-428-003, platted in Fox Bay No. 4 subdivision; 1 through 17 inclusive, platted in Hurondale Subdivision No. 1; 35 through 36 inclusive, platted in Hurondale Subdivision No. 2; and acreage parcels with sidwell numbers 12-24-403-010, 12-24-476-015, 12-24-476-020, 12-24-476-029, 12-24-477-002, 12-24-477-003, 12-24-476-027, 12-24-428-040, 12-24-428-041, 12-24-428-042, and 12-24-428-043** may be subject to assessment for benefits accruing from the proposed improvement; and

BE IT FURTHER RESOLVED, that this Board does apportion 0% of the total cost of this improvement to be borne by White Lake Township, and the remaining 100% to be assessed against the lands benefited; and

BE IT FURTHER RESOLVED, that this Board does determine that the money for the cost of the proposed improvement shall be raised in ten (10) approximately equal annual installments with interest at the rate of 6 percent per annum.

BE IT FURTHER RESOLVED, that notice of this Hearing shall be given in accordance with act 246 and that this Board hereby orders that a copy of this resolution shall be served by first class mail to each owner of, or party in interest in property to be assessed at their address as shown upon the latest local tax records.
